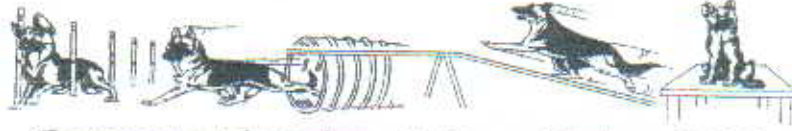
*******IMPORTANT*******

The duties of these positions are as follows:

1. **PRESIDENT** - The President presides at all meetings of the Board of Governors and the members of the club. He acts as executive head of the club and performs all duties customary and usual to the office. He acts as Chairman of the Board of Governors. He is ex-officio a member of all committees except the nominating committee.
2. **VICE-PRESIDENT** - The Vice-President shall in the absence or disability of the President perform all the duties of the President.
3. **SECRETARY** - The Secretary keeps minutes of all meetings, has charge of general correspondence, keeps the roll of the members, sends out membership cards, notifies within ten (10) days all new members of their acceptance and sends them a membership card and a copy of the By-laws, and performs all other duties customary and usual to the office.
4. **TREASURER** - The Treasurer receives, collects and handles all club funds and deposits all funds in such bank or trust company as the Board of Governors may designate and makes such disbursements there from as are necessary and proper to meet the just and due obligations of the club under the general supervision of the Board. He renders a Financial Report at the annual meeting of the members. He performs such other duties that are usual and customary to the office.
5. **HISTORIAN** - The duties of the Historian are to keep the records of the activities of the club, the members and the member's dogs.
